## ORDINANCE #120

AN ORDINANCE OF THE CITY COUNCIL OF PETROLIA, TEXAS, RESTRICTING SMOKING OR THE USE OF ANY TOBACCO PRODUCTS INSIDE ANY CITY FACILITY.

**WHEREAS**, The City Council has deemed it essential due to health, safety and sanitary reasons and for the welfare of the general public, service providers, employees and the protection of the city's property.

**WHEREAS**, there shall be no smoking or use of any type of tobacco inside of the City Hall, water plant or workshop. Smoking and/or the use of tobacco shall be permitted on city property in outdoor areas only.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PETROLIA, TEXAS:**


THAT the Petrolia City Council and Mayor are authorized to enforce the adherence of the rules for tobacco use set forth in this ordinance.

The effective date of this ordinance shall be September 18, 2012.

**ORDINANCE #119**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PETROLIA, TEXAS, AUTHORIZING THE IMPLEMENTATION OF A WATER OVER-USAGE SURCHARGE DURING THE STAGE 4 DROUGHT CONTINGENCY PLAN.

WHEREAS, drought conditions exist which represent a threat to the public health and safety; and

WHEREAS, it is necessary and in the best interests of the citizens of the City of Petrolia and its water supply to take necessary measures to conserve water.

WHEREAS, the following surcharges will be applied to any person or entity for over-usage/excessive usage of the city's water supply.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PETROLIA, TEXAS:

The over-usage surcharge will be **effective September 1, 2012** and will be applied as follows;

1. \$50.00 for usage over 15,000 gallons per monthly billing cycle.
2. \$100.00 for usage over 20,000 gallons per monthly billing cycle, in addition to surcharge #1 for excessive use.
3. \$150.00 for usage of 30,000 gallons or more per monthly billing cycle, in addition to surcharge #1 and #2 for excessive use.
