

ORDINANCE NO. 113

AN ORDINANCE AMENDING ORDINANCE NO. 112 OF THE CITY OF PETROLIA, TEXAS PERTAINING TO THE SALE OF ALCOHOL BY PROVIDING MODIFICATION OF THE CAPTION AND ORDAINING LANGUAGE OF ORDINANCE NO. 112 AS FOLLOWS: "AN ORDINANCE OF THE CITY OF PETROLIA, TEXAS PERTAINING TO THE SALE OF ALCOHOL; PROVIDING FOR PERMITS FOR THE SALE OF ALCOHOL; PROHIBITING SALE AND ESTABLISHING "ALCOHOL-FREE" ZONES WITHIN CERTAIN DISTANCES OF CHURCHES, PUBLIC AND PRIVATE SCHOOLS, HOSPITALS, DAY-CARE OR CHILD-CARE FACILITIES AND DAY SCHOOLS; PROVIDING FOR THE MEASUREMENT OF SUCH DISTANCES; PROHIBITING THE CONSUMPTION OF ALCOHOL OR POSSESSION OF OPEN CONTAINERS WITHIN THE "CENTRAL BUSINESS DISTRICT" OF PETROLIA; REGULATING THE CONSUMPTION OR POSSESSION OF OPEN CONTAINERS NEAR HOMELESS SHELTERS OR SUBSTANCE ABUSE TREATMENT CENTERS; RESTRICTING CONSUMPTION TO CERTAIN PREMISES AND PROVIDING EXCEPTIONS THERETO; PROVIDING FOR A FEE AS DETERMINED BY THE CITY COUNCIL OF PETROLIA TO BE COLLECTED FOR ANY PERMIT FOR THE SALE OF ALCOHOL; AUTHORIZING THE LEVY AND COLLETION OF LOCAL FEE NOT TO EXCEED ONE-HALF OF THE STATE FEE FOR EACH LICENSE; PROVIDING A REPEALER; PROVIDING FOR PARTIAL INVALIDITY; DECLARING AN EMERGENCY AND AN EFFECTIVE DATE. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PETROLIA, TEXAS AS FOLLOWS."

NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PETROLIA, TEXAS:

Section 1. Amendment of Caption.

Ordinance No. 112 of the City of Petrolia, Texas is hereby amended to provide a new caption and ordaining clause to said ordinance as follows:

Ordinance No. 113

“AN ORDINANCE OF THE CITY OF PETROLIA, TEXAS PERTAINING TO THE SALE OF ALCOHOL; PROVIDING FOR PERMITS FOR THE SALE OF ALCOHOL; PROHIBITING SALE AND ESTABLISHING “ALCOHOL-FREE” ZONES WITHIN CERTAIN DISTANCES OF CHURCHES, PUBLIC AND PRIVATE SCHOOLS, HOSPITALS, DAY-CARE OR CHILD-CARE FACILITIES AND DAY SCHOOLS; PROVIDING FOR THE MEASUREMENT OF SUCH DISTANCES; PROHIBITING THE CONSUMPTION OF ALCOHOL OR POSSESSION OF OPEN CONTAINERS WITHIN THE “CENTRAL BUSINESS DISTRICT” OF PETROLIA; REGULATING THE CONSUMPTION OR POSSESSION OF OPEN CONTAINERS NEAR HOMELESS SHELTERS OR SUBSTANCE ABUSE TREATMENT CENTERS; RESTRICTING CONSUMPTION TO CERTAIN PREMISES AND PROVIDING EXCEPTIONS THERETO; PROVIDING FOR A FEE AS DETERMINED BY THE CITY COUNCIL OF PETROLIA TO BE COLLECTED FOR ANY PERMIT FOR THE SALE OF ALCOHOL; AUTHORIZING THE LEVY AND COLLETION OF LOCAL FEE NOT TO EXCEED ONE-HALF OF THE STATE FEE FOR EACH LICENSE; PROVIDING A REPEALER; PROVIDING FOR PARTIAL INVALIDITY; DECLARING AN EMERGENCY AND AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PETROLIA, TEXAS AS FOLLOWS:”

Section 2. Repealer.

Any ordinance in conflict herewith is hereby repealed to the extent of such conflict. The text and body of Ordinance No. 112 except for the caption shall remain the same. Ordinance No. 112 may be amended from time to time in accordance with Texas law.

Section 3. Partial Invalidity.

Any partial invalidity of this Ordinance shall not effect the remainder.

Section 4. Declaration of Emergency and Effective Date.

An emergency is declared necessitating that this ordinance shall become effective immediately upon the passage of this ordinance.
